A short-term liquid portfolio and cash management vehicle rated AAAm<sup>4</sup> by S&P Global and permitted as an investment for all local governments under Sections 70.210 to 70.320 of the Revised Statutes of Missouri.

# **TERM PORTFOLIO**

A fixed-rate, fixed term portfolio rated AAAf by Fitch<sup>5</sup> and permitted as an investment for all local governments under Sections 70.210 to 70.320 of the Revised Statutes of Missouri.




