MOSIP was established in 1991 to provide Missouri public agencies with professional investment services.

INVESTMENT OBJECTIVE

To earn the highest income consistent with preserving principal, maintaining liquidity, and seeking a stable NAV of \$1.00.

LIQUID SERIES

A short-term liquid portfolio and cash management vehicle rated AAAM⁴ by S&P Global and permitted as an investment for all local governments under Sections 70.210 to 70.320 of the Revised Statutes of Missouri.

TERM PORTFOLIO

A fixed-rate, fixed term portfolio rated AAAF⁵ and permitted as an investment for all local governments under Sections 70.210 to 70.320 of the Revised Statutes of Missouri.

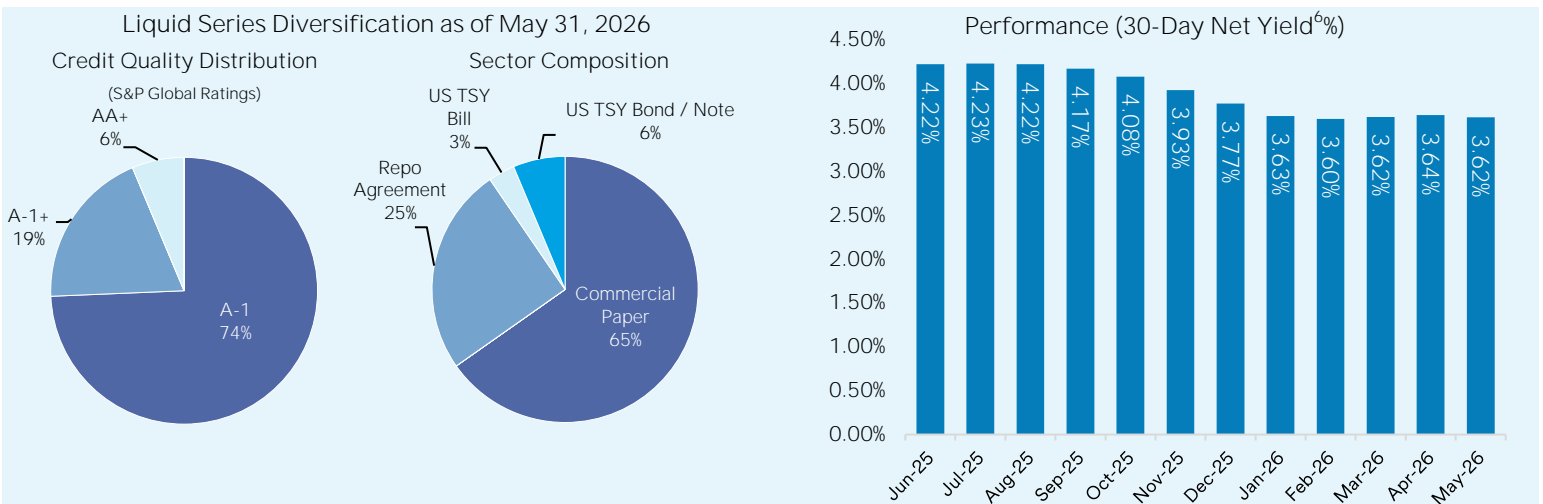

This resulting net change in account value is then annualized by multiplying it by 365 and dividing the result by 7.

² The monthly distribution yield represents the net change in the value of a hypothetical account with a value of one share (normally \$1.00 per share) resulting from all dividends declared during a month by the Pool expressed as a percentage of the value of one share at the beginning of the month. This resulting net change is then annualized by multiplying it by 365 and dividing it by the number of calendar days in the month.

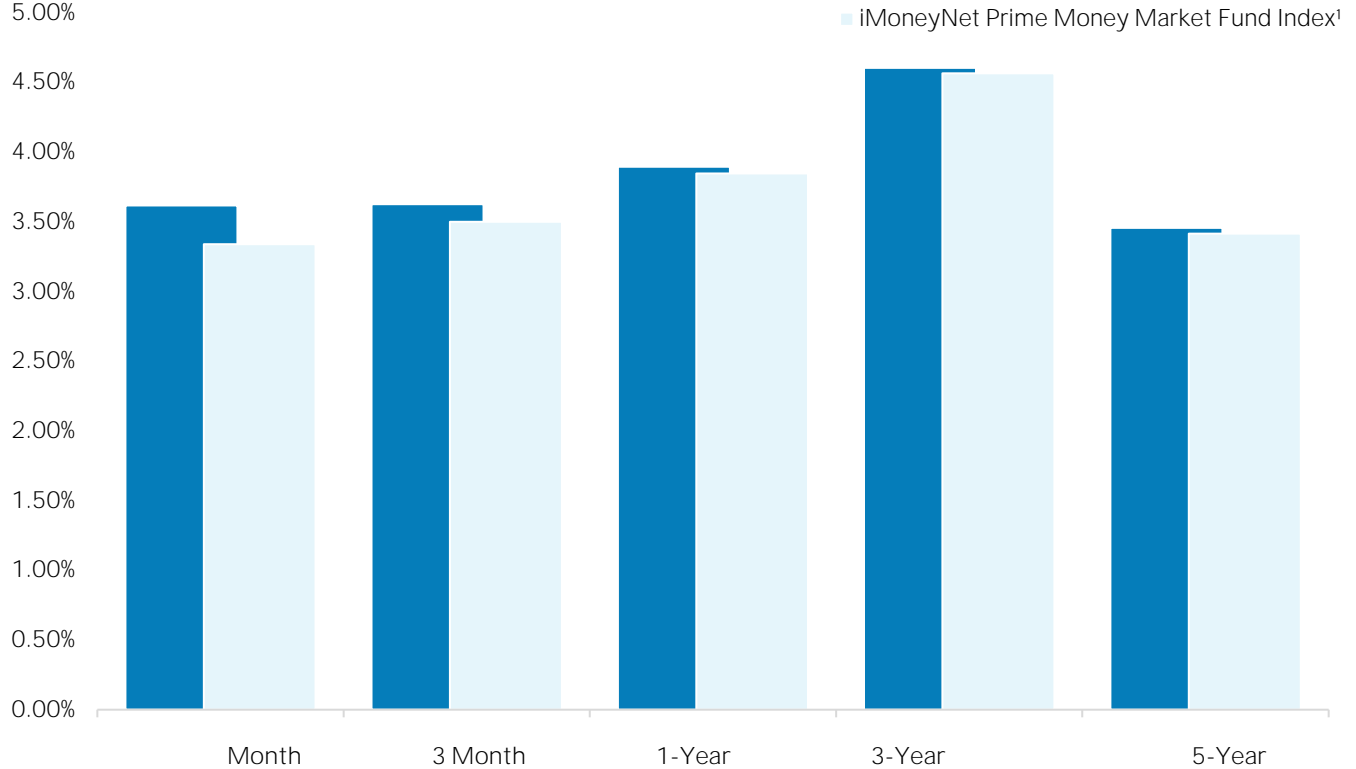
³ Weighted Average Maturity: Calculated by the final maturity for a security held in the portfolio and the interest rate reset date. This is a way to measure a fund's sensitivity to potential interest rate changes.

This resulting net change in account value is then annualized by multiplying it by 365 and dividing the result by 30.
